II. Other relevant information

Xinhua Pharmaceutical and Guangxi Dahai Sunshine Pharmaceutical Company Limited (hereinafter referred to as "Guangxi Dahai Sunshine") signed a production technology and holder transfer contract in November 2022. According to the contract, Guangxi Dahai Sunshine shall make an one-off transfer of its license concerning the Marketing Authorization Holder (MAH) status of Estazolam Tablets and all related technical ownership rights (including production approval documentation, intellectual property rights relating to production technology, commercialization rights and related rights and benefits etc., including but not limited

to from the aspects of production technology, sales and marketing, etc.) to Xinhua Pharmaceutical. The total technology transfer fee shall be payable by Xinhua Pharmaceutical to Guangxi Dahai Sunshine in accordance with staged instalments as stipulated under the contract.

Pursuant to the Rules Governing the Listing of Shares on Shenzhen Stock Exchange (深圳证券交易所股票上市规则) and the articles of association of the Company (公司章程), the present transaction is not required to be submitted for the review and approval of the board of directors or shareholders' meeting of the Company. The present transaction does not constitute a related party transaction, nor does it constitute a significant asset restructuring as stipulated in the *Measures for Administration of Material Assets Reorganization of Listed Companies* (上市公司重大资产重组管理办法).

In March 2025, Xinhua Pharmaceutical submitted application materials in connection with the change of marketing license holder of the Product to the National Medical Products Administration Drug Evaluation Center (CDE), and in April 2025, it received *Notification of Approval of Supplementary Drug Application* (药 品补充申请批准通知书). The conclusion of the review evaluation is that the application concerning the Product complies with applicable requirements for drug registration, and the change of marketing licence holder of the Product was approved.

Eszolam tablets are mainly used for anti-anxiety, insomnia or tension, fear, anti-epileptics and anti-convulsions. According to relevant data, sales of Estazolam tablets in Chinese public medical institutions amount to approximately RMB 333 million in 2023.

III. Impact on the Company and risk warning

Estazolam tablets (1mg, 2mg) were approved by the National Medical Products Administration in April 2025, and Xinhua Pharmaceutical became the marketing license holder of the Product. The launch of the Product will help enrich the Company's narcotic drug product line and enhance the Company's overall competitive advantage.

The pharmaceutical sales business is susceptible to changes in domestic pharmaceutical industry policies, bidding and procurement processes, changes in the market environment and other factors, and is subject to uncertainty. Investors are advised to invest sensibly and pay attention to investment risks.
